The general public is also hereby informed that registration of voters for the fourth quarter of 2024, is now in progress. All prospective voters **MUST** meet the registration qualifying criteria as set out in the Anguilla Constitution Order 1982 Section 43(1). For the avoidance of doubt, this includes documentary evidence of Anguillian status and proof of residence in the district they wish to be registered in.

Registration for the fourth quarter of 2024 will close on the **9th November, 2024** and can be done at the Central Electoral Office between the hours of 8:30am to 3:30pm, Monday - Friday.
