- (a) The quarterly list of voters for this Electoral District will be revised on MARCH 12th, 2025;
- (b) any person who—
- i. holds a certificate of provisional registration and whose name, address or occupation has been omitted from or incorrectly stated in this quarterly list, or
- ii. applied to be registered on this quarterly list and did not receive a certificate of provisional registration, but believes he/she is qualified to be registered; may give notice in **Form 7** to the Electoral Registration Officer at the Central Electoral Office on or before **3:00pm Thursday 6<sup>th</sup> February 2025**, claiming that his/ her name, address or occupation be inserted in the list or that the entry relating thereto be corrected, as the case may be.
- (c) Any qualified person whose name appears on more than one quarterly list is required to give notice in **Form 9** to the Electoral Registration Officer at the Central Registration Office on or before <u>3:00pm Thursday</u> 6<sup>th</sup> February 2025.
  - i. electing the Electoral District in which he/ she desires to be registered,
  - ii. specifying the other electoral district in relation to which his/ her name is listed on the quarterly list, and
  - iii. requiring the Electoral Registration Officer to delete his name from the other quarterly list;
- (d) Any qualified person whose name is spelt incorrectly on this quarterly list is required to give notice in **Form**10 to the Electoral Registration Officer at the Central Electoral Office on or before 3:00pm Thursday 6<sup>th</sup>

  February 2025;
- (e) any qualified person whose name appears on the existing register of voters, may give notice in **Form 8** to the Electoral Registration Officer at the Central Electoral Office on or before <u>3:00pm Thursday 6<sup>th</sup> February</u> <u>2025</u>, objecting to the inclusion on this quarterly list of any other person on the ground that that person is not a qualified person;
- (f) copies of the forms mentioned above may be obtained at the Central Electoral Office.
